### Summary of Portable Batteries Data for the 2015 Compliance Period - as at 27 June 2016

#### Data Summary

The UK collection rate is calculated from the weight of waste portable batteries for which schemes supply battery evidence notes in 2015. Evidence can be issued by ABTOs and ABEs on all waste portable batteries received for treatment/export in 2015. The UK has met and exceeded the collection rate target of 40% for 2015.
