### Summary of Portable Batteries Data for the 2010 Compliance Period - as at 18 July 2012

#### Data Summary

The UK collection rate is calculated from the weight of waste portable batteries for which schemes supply battery evidence notes in 2010. Evidence can be issued by ABTOs and ABEs on all waste portable batteries received for treatment/export in 2010.
