Summary of Portable Batteries Data for the 2017 Compliance Period - as at 31 May 2018

Data Summary

The UK collection rate is calculated from the weight of waste portable batteries for which schemes supply battery evidence notes in 2017. Evidence can be issued by ABTOs and ABEs on all waste portable batteries received for treatment/export in 2017. The UK has not met the Collection Rate Target.
