Data Summary

The UK collection rate is calculated from the weight of waste portable batteries for which schemes supply battery evidence notes in 2024 Evidence can be issued by ABTOs and ABEs on all waste portable batteries received for treatment/export in 2024. The UK has not met the collection rate target with a collection rate of 44.93%
