### Summary of Portable Batteries Data for the 2018 Compliance Period - as at 28th May 2018

#### Data Summary

The UK collection rate is calculated from the weight of waste portable batteries for which schemes supply battery evidence notes in 2018. Evidence can be issued by ABTOs and ABEs on all waste portable batteries received for treatment/export in 2018. The UK has achieved its collection rate with a rate of 45.23%
