### **Summary of Portable Batteries Data for the 2013 Compliance Period - as at 26 June 2014**

---

#### **Data Summary**

The UK collection rate is calculated from the weight of waste portable batteries for which schemes supply battery evidence notes in 2013. Evidence can be issued by ABTOs and ABEs on all waste portable batteries received for treatment/export in 2013. Compliance schemes have until 31 May 2014 to obtain evidence to meet their members' obligations for the 2013 compliance period.

The UK target collection tonnage for 2013 is 30% of the average annual amount of portable batteries placed on the UK market by scheme members and small producers in 2011, 2012 and 2013.
