Summary of Portable Batteries Data for the 2016 Compliance Period - as at 30 June 2017

Data Summary

The UK collection rate is calculated from the weight of waste portable batteries for which schemes supply battery evidence notes in 2016. Evidence can be issued by ABTOs and ABEs on all waste portable batteries received for treatment/export in 2016. The UK has not met the collection rate target of 45% for 2016.
